Jay Doegey, City Attorney, presented to Council the proposed amendments to the "**Sexually Oriented Business**" Chapter of the Code of the City of Arlington, Texas 1987.

Councilmember Wright made a motion to approve on first reading an ordinance amending the "**Sexually Oriented Business**" Chapter of the Code of the City of Arlington, Texas, 1987, through the amendment of **Article I, Purpose and Intent, Section 1.03, Findings**, relative to the addition of cases and studies; through the amendment of **Article VI, Miscellaneous, Section 6.03, Additional Regulations Concerning Public Nudity**, Subsection (B), relative to clarification of materials to be used to satisfy the requirements of an "enclosed performance stage"; providing this ordinance be cumulative; providing for severability; providing for governmental immunity; providing for publication and becoming effective ten days after first publication. Seconded by Councilmember Wilemon, the motion carried with 9 ayes and 0 nays. **(FIRST READING)**
